1. Payments for goods and/or services shall be payable to Jaytron, Inc. at 2635 Manatee Avenue East, Bradenton, FL 34208. Unless otherwise mutually agreed upon, accounts are C.O.D. company check accepted. For due on receipt accounts (10 days), payments will be applied on an invoice open basis. Dealer agrees to accept orders C.O.D. plus a payment on account if the account ages over 15 days, and Dealer agrees to a service charge of 1 1/2% on balances aged over 30 days.

2. Delivery and Shipping All goods are shipped FOB Jaytron's Bradenton facility. Shipping expenses, claims for damaged goods, or claims for lost goods are the responsibility of Dealer. Jaytron will assist Dealer in every way possible with the filing of such claims, when and if they should happen. Shortages must be reported to Jaytron within 48 hours of receipt.

3. Returns will be accepted by Jaytron if product is returned within 30 days of date of invoice and packaging is still in new condition ready for resell. Returns will not be accepted for full credit if manufactures packaging is defaced, marked on or manipulated. Returned packages may be accepted and be subject to a 15% restocking fee if returned in their original condition and original packaging after 30 days of date of invoice, or in a marked/damaged box. All credit for returns will be at the sole discretion of Jaytron. Returns for exchange will be made only if in original condition and packing according to manufacturers policy and/or procedures.

4. Warranties Jaytron makes no warranty on any goods sold. All warranties, implied or otherwise, are borne by the individual manufacturer. Copies of these warranties are available upon request.

5. Collection If collection of any Dealer account becomes necessary, Dealer agrees to pay costs of collection plus attorney's fees.

6. Agreement Each of the parties hereto understands and agrees that this constitutes the entire agreement of the parties.
